#### Circumstances of Accident

I Gared Wee Yuan Lun S9624841E driver of SLZ856T on the 24th July 2019 1700hr was slowly moving behind Car X with a car plate number of SLJ9029P to make a left turn from a minor road into a major road. Car X did not stop at the stop line of the junction and had committed to the left turn and hence I continued to move slowly before him. As I was next in line to make the left turn I looked to the right to ensure there was no oncoming traffic but while doing so car X has suddenly braked ahead of me with his car having crossed the stop line entirely. This caused me to lightly bump into him because 1. I could not react in time and 2. I did not expect him to stop in the middle of a junction. There was no damage sustained to my vehicle and a slight dent was sustained on his bumper. The bumper was observed to be aligned with the car body perfectly (back and both sides) and the only damage observed was the aforementioned dent. I did not notice any passengers in the vehicle as only the driver came out. Driver X informed that car X is rented from a rental company by the name of Mcqueen Car Rental. It was noted the rental price on facebook for per day rental for this car was \$58




