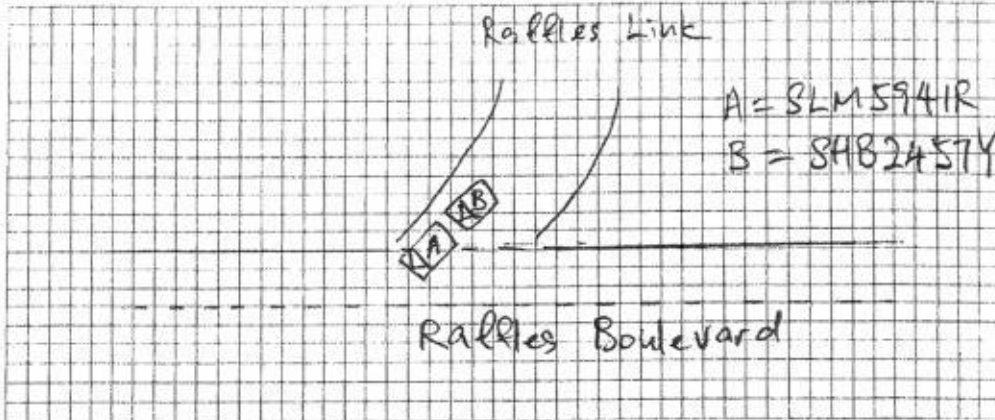

I was waiting at Raffles Link exit for clear traffic to proceed onto Raffles Boulevard.


As I inch forward and check on the oncoming traffic from my left, I suddenly heard a bang.


