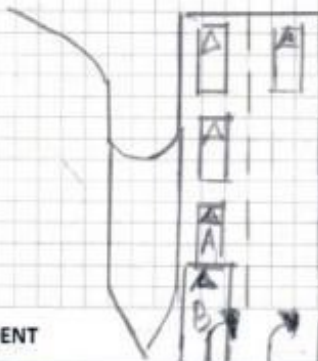
Accident Sketch Plan
