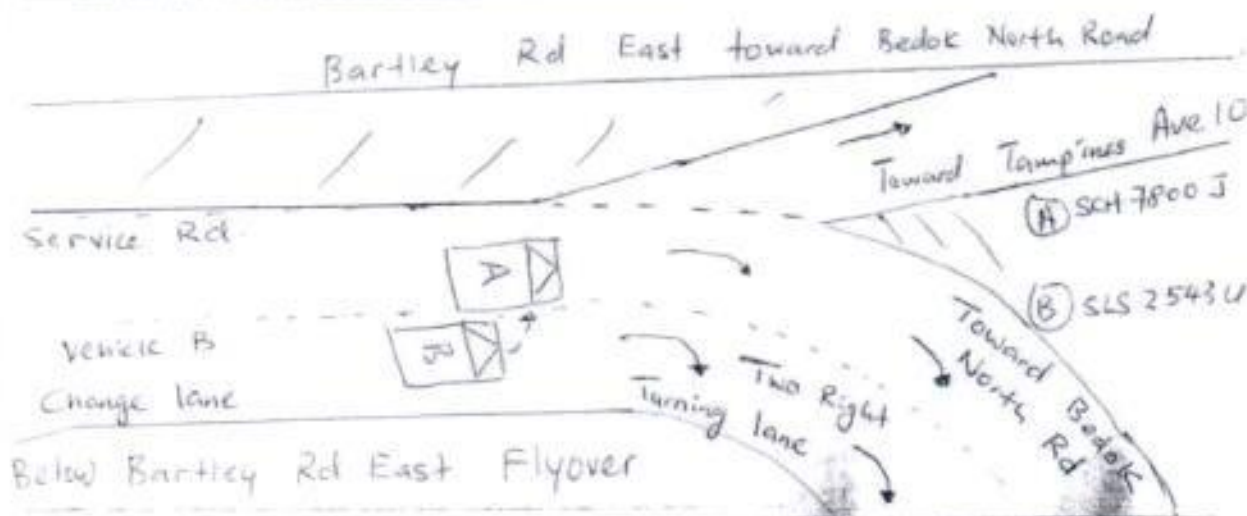

Sketch Plan



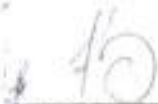
