Brief Details.

On the 31/7/2019 at about 1700hrs, I was driving my vehicle(SKG3049Z) along Telok Blangah Street 31(Near to the T junction). I wish to state that there are only two lanes along the said road, and my vehicle was on the left lane while the other vehicle(S1)-(SMC1762H) was on my right. At the point in time, the traffic was heavy. Subsequently, when I was about to exit the said street turning into West Coast highway, S1 drove into my lane and his front left side of his vehicle bumped into the front of my vehicle. As a result, my vehicle front bumper dropped down. Even though S1 had bumped into my vehicle, he did not stopped his vehicle but had continued to drive. Consequently, his left side of his vehicle was scratched. S1 then stopped his vehicle after I have horned him. Both parties alighted the vehicle and exchanged particulars, the driver of S1 had also admitted that his fault. At that point in time, my vehicle camera is not working but I believed his vehicle camera is working. S1 is also a grab driver. After the accident, I went to Mount Elizabeth hospital at NOVENA, and the doctor said that I had strained my neck due to the accident and had given me 5 days of MC.


