

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT (A) STS 8399K (B) SHD 5606D

On 02/08/2019 at about 0920 hrs at Junction of Beach Road and Ophir Road. I was travelling on the lane 2 along Beach Road towards Crawford Street and came to a stop behind few vehicles at the above mentioned junction. I 'row' my left signal and had checked that the blindspot and the lane 3 was cleared of traffic before I veered out towards lane 3. While doing so, a Vehicle (B) travelling along lane 4 veered into lane 3 with fast speed and without any reason as his lane was totally cleared of traffic and recklessly collided onto my left portion of my vehicle (A) causing damages to my vehicle. I had CCTV footage and will forward to police for their onward action.


