Due to the impact, the vehicle then hit onto the water barrier on chevron marking. My vehicle sustained scratches on the front right bonnet. I suffered whiplash to the neck. I have an in car camera in my vehicle which records down the incident.

I seek medical treatment and was given seven (7) days of medical leave.
