

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

4:38pm 4th August 2019 : Came to a halt at the traffic light but the car rolled and kissed the bumper of the car in front. Both the driver and I came out of the car to inspect and we both concluded that there was "no visible damage". We exchanged contacts and for both parties drove off afterwards. After about 30 minutes, the driver called to say that there was a scratch/crack at his bumper above the right reverse sensor. This was absurd since: (1) We both concluded that there wasn't any ^{visible} damage before we drove off and (2) my vehicle kissed his bumper in the middle ~~supported with video evidence~~ but the scratch/crack was on the right side of the bumper. Furthermore, he claimed that the crack/scratch only formed after the accident.
