Brief details.

On the 27/07/2019 at about 1330hrs-1400hrs, I had cleared the Singapore Checkpoint and was proceeding to Johore Bahru. While on the way in the vehicle SMG7207J Hyundai "Avante" going down slope I tap on the brake, the brake paddle was slightly harder to compress however still managed to brake. The front portion of the vehicle also vibrated slightly. I was also still in Singapore boundary when a driver of a passing vehicle had signaled to me informing me that there was smoke coming out from the front of my bonnet. I then signaled left and stopped my vehicle. As soon as I signaled, the fire ignited

from the front bonnet. I immediately exited my vehicle, took my handphone and passport.

A few passerby assisted me with the fire extinguisher however did not dare to move close to the vehicle as the fire was getting bigger as the time past. I then informed my boss Azmi c/n:96686369 who then advised me to take pictures of the vehicle on fire and will update the car rental company.

Subsequently ICA, plain clothes police officers came to me and asked me what happened to the car and what happened. I told them it suddenly caught fire and requested for my details. I provided them with my passport, they made a check with me from where the car was rented and I informed them that it was from AARIS PTE LTD located at Blk 56 Cassia Crescent #14-13 and liaise with Kishore c/n:97791554 whom I had signed the contract with at Turfcity.

Moments after Traffic Police and SCDF arrived. SCDF managed to put off fire and was subsequently towed by ICA to Woodlands Checkpoint arrival car secondary team office. Rental company tow truck then towed the vehicle from there.

The front portion of the vehicle was totally damaged. There was no damage to any government property and I can affirmed it even after they had towed the vehicle the road only had debris from my vehicle and no damage to the road. This was first time such incident happened even though I had enter and exited several times for this week. I also wish to state that I had made a thorough check on the coolant, battery, engine oil and also took a look at the engine compartment before moving off. I am lodging this report for my own record purposes.
