Circumstances of Accident

AS I WAS TRAVELLING ALONG THE 2ND LANE OF VICTORIA STREET WITH ONE MALE CHINESE (FOREIGNER STUDENT) PASSENGER ON BOARD, SUDDENLY THE FRONT VEHICLE SLM2951G BRAKE AND STOPPED, I IMMEDIATELY APPLY MY BRAKE AND STOP HOWEVER I FELT AN IMPACT ON MY REAR. I IMMEDIATELY TURN AND CHECKED MY PASSENGER WAS BLEEDING AT THE NOSE AND EYES. I ALIGHTED AND CHECKED THE VEHICLE SMA6006K HAD HIT ONTO MY REAR OF MY TAXI. THE SMA600K DRIVER CALLED FOR AMBULANCE. THE MALE CHINESE (FOREIGNER STUDENT) PASSENGER LEFT THE SCENE IN A HURRY BEFORE THE POLICE AND AMBULANCE CAME. THE FRONT VEHICLE SLM2951G CLAIMS THAT I HIT ONTO HIS VEHICLE. 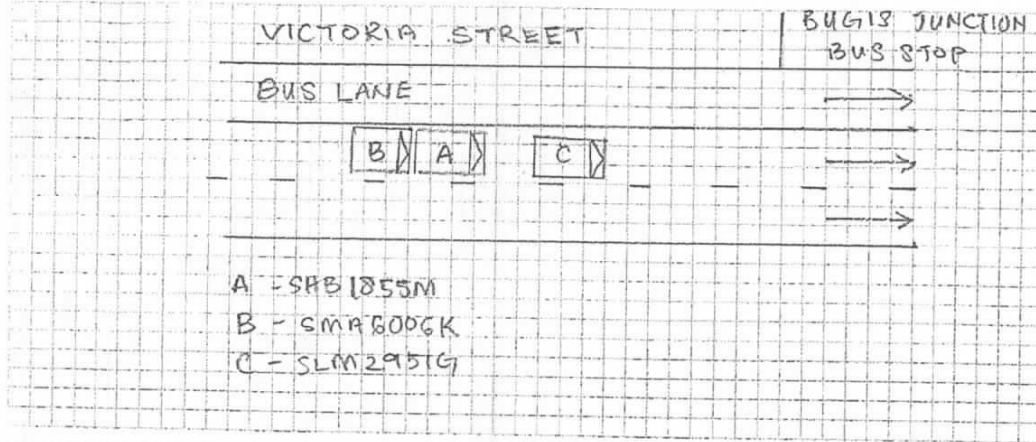

SKETCH PLAN

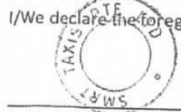
