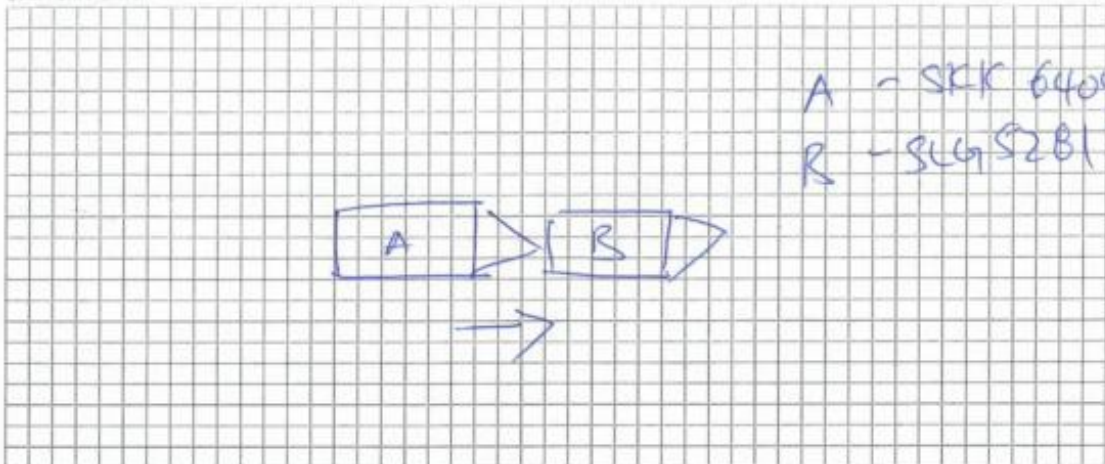

- ③ moved forward after green
- ④ car in front jam brake (trying to avoid car in front turning into
hit lane) SLG 5281T
- ⑤ I jam brake.
- ⑥ unable to brake in time and banged into the car SLG 5281T
