Dear Sirs,

May I seek your assistance to perform a detailed mechanical inspection of the 13 vehicles below: [The ones marked in RED are deemed to be URGENT hence please EXPEDITE ON THESE REQUESTS]

a) Case IAFP-IB-20190708 - Mechanical Inspection of Motor Van, GBF7017T (TP/IP/23469/2019)

On 7 April 2019 (Sunday) sometime before 7.44 am, the Involved Party (van) was travelling on the right lane of 2 lanes along Sembawang Way towards Canberra Link. After the junction of Admiralty Drive, the Deceased crosses from Involved Party left to right view beyond 50 meters of the pedestrian crossing. The Involved Party unable to avoid thus the front right portion of the said motor van collided onto the Deceased. Upon impact, the Deceased was flung and landed on the centre divider grass patch. Due to the collision, the Deceased sustained laceration on her right forearm and head injury. The Deceased was conveyed in an unconscious state by an ambulance to Khoo Teck Puat Hospital (KTPH). However, on the same day, he she succumbed to her injuries. The Deceased was pronounced dead in Khoo Teck Puat Hospital, A & E Department at 9.08 a.m., by Doctor John Chua.

b) Case IAFP-IB-20190708 - Mechanical Inspection of Police Motor Car, QX1024Y (TP/IP/38815/2019)

On 19 June 2019, at about 12.52pm, the Driver of QX1024Y (B1) was travelling along lane 1 of 2 lanes road of Serangoon Avenue 2 towards Upper Serangoon Road. A motor car, SLH3531E (A1), ahead of B1 had come to stop, waiting to turn right into the carpark of Blk 304. B1 claimed that due to faulty brakes, he was unable to stop in time and collided onto the rear of A1.

On 14 June 2019 at about 10.03 am, the deceased was riding motorcycle FBP 6474 T in between lane 1 and lane 2 of 3 lanes along AYE towards MCE 12 km, when motor van GBE 3035 E travelling on lane 2 switched lane to lane 1 and side swiped onto the motorcycle. The rider of the motorcycle was sent to NTFGH and died 4 days later.

On 29 June 2019 at about 12.33 pm, the deceased riding motorcycle FBP 1505 X was travelling on lane 1 of 4 lanes road along AYE towards CTE when the rider collided onto the rear of motor car SDH 2822 S on lane 1 before falling onto lane 2 and colliding onto the right side of the tipper XD 6857 A. The rider died on the spot.

h) Case IAFP-IB-20190708 - Mechanical Inspection of Motor Car, SGD5561K (TP/IP/34807/2019)

On 2 June 2019 (Sunday) at or about 1.03am, the motor car driver was travelling along the single lane carpark of Stadium Boulevard when the front right portion of his m/car collided onto the Deceased who was walking on the right side of the carpark. After the impact, the Deceased fell and was run over by the left tyre of the m/car. As a result of the accident, A1 sustained head injuries and was conveyed to Tan Tock Seng Hospital in an unconscious state. At the hospital, the Deceased succumbed to his injuries and was pronounced dead at 1.45 am.

i) Case IAFP-IB-20190708 - Mechanical Inspection of Garbage Truck, XD6910D (TP/IP/36651/2019)

On 10 June 2019 (Monday) at about 12.58pm, driver of garbage truck had just finished loading garbage at Blk 179 Yun Sheng Rd loading/unloading bay. As he started to move off and made a left turn towards the carpark exit, he suddenly felt a bump. He immediately stopped to check and saw pedestrian (deceased) underneath his truck, just behind the right front tyre. As a result of the accident, pedestrian sustained head injuries and was pronounced dead at scene at 1.11pm by Paramedic Sgt Siti.

On 24 June 2019 (Monday) at about 7.37 am, the deceased was travelling on the right lane of 2 lanes along Choa Chu Kang Ave 1 towards Teck Whye Crescent, when he suddenly lost control, mounted the centre divider before colliding onto a tree. Due to the impact, the deceased landed beside the tree while his helmet was flung to the opposite road. As a result of the accident, the Deceased sustained head injuries and was conveyed to National University Hospital in an unconscious state. At the hospital, the Deceased succumbed to his injuries and was pronounced dead at 8.55am.

On 24 June 2019 (Monday) at about 7.37 am, the deceased was travelling on the right lane of 2 lanes along Choa Chu Kang Ave 1 towards Teck Whye Crescent, when he suddenly lost control, mounted the centre divider before colliding onto a tree. Due to the impact, the deceased landed beside the tree while his helmet was flung to the opposite road. As a result of the accident, the Deceased sustained head injuries and was conveyed to National University Hospital in an unconscious state. At the hospital, the Deceased succumbed to his injuries and was pronounced dead at 8.55am.

- m) **Case IAFP-IB-20190708 - Mechanical Inspection of Motor Lorry, GBJ253K (TP/IP/40685/2019)**

On 30 June 2019 (Sunday) at or about 7.07 a.m., The Witness claimed that he was travelling along New Upper Changi Road towards the direction of Upper Changi Road East on lane 1 of the 4-lanes road, directly behind of the Accused's motor lorry. He then noticed that the Accused's motor lorry was making a right turn into Bedok South Road on green light only and in the midst of doing so, the frontal right portion of the Accused's motor lorry collided into the Deceased who was still walking along the signalised pedestrian crossing while on flickering green man, ahead of the Accused's motor lorry from the Accused's right side to left side. Due to the collision, the Deceased was reported to be unconscious and case was classified as standby due to trauma thus he was conveyed by an ambulance to Changi General Hospital. However, on the same day at 8.50 a.m., the Deceased had succumbed to his injuries and he was pronounced dead by Dr Jonathan in Changi General Hospital.
