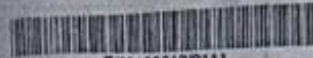



Brief Details.

ON THE ABOVE MENTIONED DATE, TIME AND LOCATION,

I WAS TRAVELLING ON CTE ALONG UPP SERANGOON RD ON THE FIRST LANE. DUE TO A PUDDLE ON THE ROAD, THE CAR SKIDDED AND I TRIED TO COUNTER STEER MANY TIMES TO TRY TO GET BACK CONTROL AND THE CAR SWERVED LEFT AND RIGHT FOR SOMETIME BUT COULD NOT CONTROL IT AND THE CAR SKIDDED TO THE RIGHT SIDE AND COLLIDED TO THE BARRIER. AFTER THE COLLISION I THEN SAW A MOTORCYCLE THAT WAS LYING ON THE ROAD. THEN I GOT OUT OF THE CAR TO CHECK WHERE IS THE MOTORIST. THEN I SAW THE MOTORIST STAND UP AND THEN WENT TO THE SIDE OF THE ROAD. A PASSERBY STOPPED MY VEHICLE AND CHECKED ON ME. I TOLD HIM I WASN'T FEELING WELL, AS I WAS FEELING NAUSEA AFTER THE IMPACT.
