We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, **AIG Asia Pacific Insurance Pte Ltd** to deal with the third party claim against your policy.

We have received a claim from **SJS 8435H** against your motor insurance policy.

Based on the circumstances of accident and both parties damage profile, we opine that both vehicles should exercise caution as third party vehicle is going down a slope and your vehicle was reversing to park into the parking lot. As such, we as the appointed agent of your insurers shall proceed to negotiate for an amicable settlement with third party claimant to settle the matter at best.
