


I was travelling on Kung Chong Rd and passing through Hoy Fatt Rd towards Leng Keng Community Centre at 1804hrs.

As I approaching the traffic junction with Stop Sign, I slow down and as I see not car on the right of Hoy Fatt Rd, I continue to move out of the stop line slowly. When my car almost reached the centre of the lane on Hoy Fatt Rd, I sudden saw a brown Honda Vezel rushing over in front of me front the right and I was unable to stop as I just moved out from the Stop Line.



### Brief Details.
