**Brief Details.**

On the 2/8/2019 at about 1334hrs, I was driving my 13-seater mini bus bearing registration number PA7197A and into the carpark behind Bukit Panjang Community Centre and into lot no. 995. I was about to alight from the vehicle to a nearby coffee shop. However, I decided not to and moved out from the lot after checking no car was coming in my direction. Out of a sudden, a car came from my right and bumped onto my vehicle so hard that it caused my vehicle to turn about 90 degree to the left. My vehicle then bumped onto a Singtel van bearing registration number GU9074J that was parked in the lot no. 997. The collision resulted in me experiencing black out for about 3 seconds.

The car bearing registration number SJL9013Y was moving so fast and she alighted from her car, informing that she is a Grab driver and has a passenger on her car. Traffic police and ambulance arrived at scene. The driver was conveyed by the ambulance. There was camera installed in my bus two Samsung 32GB memory cards were taken by the Traffic Police officers. The front right bumper of my vehicle is damage.

On the same day at about 1645hrs, I had consulted medical assistance at the National University Hospital and was given 5 days medical certificate from today until 6/8/2019. I feel pain from my neck to back area.


