ACCIDENT INVOLVING SDY 3368R(AXA) AND SLJ 2517T ALONG/AT PARKWAY PARADE CARPARK LOT 623 4TH FLOOR ON 06/08/2019

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a third party claim(s) from 96 MOTORSPORTS PTE LTD acting on behalf of the owner of SLJ 2517T against your motor insurance policy.

Based on the accident report and accident scenario, liability is not in your favour as your vehicle was coming out from parking lot and collided with third party vehicle. 


