May I seek your assistance to perform a detailed mechanical inspection of the 10 vehicles below:

a) Case IAFP-IB-20190802 - Mechanical Inspection of Motorcycle, FBM4907R (TP/IP/42471/2019)

On 8 July 2019 (Monday) sometime before 5.44 pm, the Deceased was travelling straight along Tampines Expressway towards the direction of Seletar Expressway, 7km on lane 2 of the 3-lanes road when he ran over a stone on the road, causing him to lose control, self-skidded and landed on lane 3. Due to the accident, the Deceased who was reported to be unconscious and sustained multiple injuries was conveyed to Khoo Teck Puat Hospital by an ambulance. However on 9 July 2019 at 9.56 am, the Deceased succumbed to his injuries and he was pronounced dead by Dr Li Qi Jonathan Ricky.

b) Case IAFP-IB-20190802 - Mechanical Inspection of Motorcycle, JNF9548 (TP/IP/43851/2019)

On 15 July 2019 (Monday) sometime before 7.49 am, the Deceased was travelling straight along Pioneer Road towards the direction of Jalan Buroh when he lost control of the motorcycle, veered to the left, collided into the left curb side of the road and subsequently skidded on the road. Due to the accident, the Deceased who was reported to be unconscious and sustained facial injuries with suspected cardiac arrest was conveyed to Ng Teng Fong General Hospital by an ambulance. However on 15 July 2019 at 9.26 am, the Deceased succumbed to his injuries and he was pronounced dead by Dr Michael Choo.

c) Case IAFP-IB-20190802 - Mechanical Inspection of Motorcycle, JSK1728 (TP/IP/45247/2019)

On 21 July 2019 (Sunday) sometime before 6.00 am, the Deceased and the pillion rider were on the motorcycle and were travelling straight along Tuas South Blvd towards the end, after Tuas South Way. While travelling on lane 1 of the 3-lanes road, the motorcycle veered to the right, mounted the centre divider and landed on the grass verge of the centre divider. As a result of the accident, the Deceased and pillion rider sustained multiple injuries and were conveyed to the Ng Teng Fong General Hospital by ambulance. The Deceased, who was reported to be unconscious, suffered a cardiac arrest. He succumbed to his injuries and was pronounced dead in hospital on the same day at 7.13 a.m., by Dr Wilona Lee. The pillion rider is currently admitted in Ng Teng Fong General Hospital, Tower B, Ward 8, Bed 18A for follow-up treatment.

d) Case IAFP-IB-20190802 - Mechanical Inspection of Motorcycle, FBC2407H (TP/IP/47301/2019)

e) Case IAFP-IB-20190802 - Mechanical Inspection of Motor Lorry, YN668D (TP/IP/47301/2019)

On 30 July 2019 (Sunday) sometime before 9.26 pm, the motor lorry (B1) was travelling along Harbour Drive towards Pasir Panjang Road on the lane 2 of the 3-lanes road. Upon reaching the signalised T-junction of PSA Gate 4 Entrance, the traffic light signal was showing red light. Hence, B1 come to a stop before the junction. After the traffic light signal turned 'green-only', B1 proceed to make a right turn into PSA Gate 4 Entrance. Out of a sudden, B1 saw the motorcycle (A1) travelling at a fast speed from the opposite direction. The front portion of A1's motorcycle then collided into the left front corner of B1's motor lorry. As a result of the accident, A1 sustained lower right limb near amputation and was conveyed conscious to National University Hospital by an ambulance. However on the same day at 2.18 am, A1 succumbed to his injuries and was pronounced dead by Dr Menon.

On 6 July 2019 at about 5.37 pm, the deceased was riding motorcycle FBC 4128 A T along Gul lane when the bike collided with motor lorry YN 5091 J that was travelling along Gul Crescent. As a result of the accident the rider dies at the scene while the pillion was sent to NUH in an unconscious state.

On 13 July 2019 at about 1.09 am, the deceased riding motorcycle FBD3852T along Woodlands Avenue 1 when he lost control of his motorcycle, hit the left kerb mounted the kerb and collided onto a lamp post. Rider was sent to KTPH unconscious and he succumbed to his injuries in hospital.

On 17 July 2019 (Wednesday) at about 10.03 p.m., the Potential Defendant drove his motorcar on lane 2 of the 4 lanes of Tampines Avenue 2 towards Tampines Avenue 9. At the signalised cross junction of Tampines Street 32, the Potential Defendant made a right turn into Tampines Street 32 towards Tampines Street 33, when the traffic light signal was showing amber. At the same time, the Deceased was riding his motorcycle from the opposite direction along Tampines Avenue 2 towards Tampines Avenue 1, when he collided onto the left front portion of the Potential Defendant's motorcar. Due to the accident, the Deceased was conveyed by ambulance to the Changi General Hospital however, he succumbed to his injuries and was pronounced dead in hospital on the same day, at 11.18 p.m. by Dr Quek.
