**Subject:** Mechanical Inspection Report Request

Dear Sirs,

May I seek your assistance to perform a detailed mechanical inspection of the **9 vehicles** below:

**a) Case IAFP-IB-20190820 - Mechanical Inspection of Police Hilux, GZ3294D (TP/IP/47933/2019)**

On 1 August 2019 (Thursday) sometime before 4.05 pm, the Police Hilux, GZ3294D, was travelling on left of 2 lanes and negotiating a right bend. After the right bend, driver applied her brakes and discover it was not working. Driver was unable to stop in time and collided into a stationary taxi causing it to surged forward and collided onto a stationary motor car ahead. The driver then claimed mechanical fault to the FRV. She informed the vehicle was fine while attending to a case but heard a "Gear Box Rattling Sound " coming from the engine. She did not report the matter to her Transport in charge hence she proceeded to the next case and the RTA occurred. Due to the RTA, rear passenger, Female /77 Years Old /Malay, of the taxi sustained a back pain, conveyed to CGH by ambulance a. She was treated as outpatient with 4 days of medical leave.

**b) Case IAFP-IB-20190820 - Mechanical Inspection of Motor Taxi, SHC7245D (TP/IP/23457/2019)**

On 7 April 2019 (Sunday) at or about 12.02 a.m., the Deceased who was walking alone in an unsteady manner and was hailing a taxi from the pavement along Sentosa Gateway. The Deceased then took a step forward when he tripped and fell off the pavement. The Deceased landed on the road, lying in between lanes 3 and lane 4 of the 4-lanes road. The Accused's motor taxi was travelling on lane 3 when he ran over the Deceased. After collision, the Accused stopped by the side of the road and alighted from his motor taxi. However, he left the scene shortly after without reporting the accident. Due to the collision, the Deceased was pronounced dead at the scene by AB121, Paramedic SGT Ken at 12.11 a.m.

**c) Case IAFP-IB-20190820 - Mechanical Inspection of Motor Van, GBB4314J (TP/IP/46503/2019)**

On the 27 July 2019 (Saturday) sometime around 5.09 p.m., the motor van was driving inside multi-story car park on single lane on-way road (up slope) in which he claimed that the steering wheel of his motor van was not functioning. The driver was unable to steer right of his motor van and the motor van automatically swerve to the left. The said motor van then side-swiped onto the side wall on the left side.

**d) Case IAFP-IB-20190820 - Mechanical Inspection of Motor Car, SMK3217K (TP/IP/46503/2019)**

On the 31 July 2019 (Wednesday) sometime around 6.08 p.m., the motor car was travelling on lane 2 of 2 lanes along Serangoon North Ave 5. While proceeding across the T-junction of Serangoon North Ave 5 by Serangoon North Ave 6, the motor car collided into a pedestrian who was crossing from his left to right at the pedestrian crossing on red man. The pedestrian was conveyed unconscious and subsequently died due to his injuries on 13 August 2019.

**e) Case IAFP-IB-20190820 - Mechanical Inspection of Motor Van - GBF5904D (TP/IP/50679/2019)**

On 15 August 2019 (Thursday) sometime before 3.27 pm a.m., the Accused was driving a motor van, GBF 5904D, along a single traffic along Tao Ching Road towards Corporation Drive. Approaching a non-signalised T-junction of Tao Ching Road by Corporation Road, the Accused made a left turn into the left lane of 2-lanes of Corporation Drive towards Yung Ho Road. While the Accused was in the midst of turning left into Corporation Drive, the Deceased was crossing from the Accused's left to right view. The Accused front portion of the motor van hit onto Deceased's left side and subsequently ran over the Deceased. As a result of the accident, the Deceased sustained injuries on the upper and lower abdomen. She succumbed to her injuries and was pronounced dead at scene at paramedic Sgt Helmi at 3.45 p.m.

**f) Case IAFP-IB-20190820 - Mechanical Inspection of Motorcycle - FBD4157K (TP/IP/39375/2019)**

On 22 June 2019 (Sunday) sometime before 3.14 p.m., the Deceased was riding his motorcycle on lane 2 of 4-lanes along BKE towards Woodlands Checkpoint Somewhere before the viaduct into Woodlands Checkpoint, suddenly lost control and self-skidded. Deceased landed on the road on lane 2 and was conveyed by the ambulance to KTPH for multiple injuries. He was admitted in the Intensive Care Unit (ICU). On 23 July 2019, the deceased was pronounced dead at 3.02 a.m. in KTPH.

**g) Case IAFP-IB-20190820 - Mechanical Inspection of Motorcycle - FN17H (TP/IP/39375/2019)**

On 29 July 2019 (Monday) sometime before 8.35 p.m., the accused was riding his motorcycle on lane 2 of 2-lanes along Sungei Kadut Street 1 when he noticed a road sweeper ahead. Rider informed he tried to swerve his motorcycle to the right however in the process of doing so, lost control and skidded to the right and collided onto the centre divider and the road signage. Rider and his pillion(Deceased) landed on the road on lane 1. Both of them were conveyed by the ambulance to KTPH for multiple injuries. The Deceased was admitted in the Intensive Care Unit (ICU) and on 13 August 2019, the deceased was pronounced dead at 12.03pm.

**h) Case IAFP-IB-20190820 - Mechanical Inspection of Motor Car - SMH5996Y (TP/IP/49955/2019)**

On 13 August 2019 (Tuesday) at about 9.08 a.m., the Involved Party was travelling straight along Tiong Bahru Road towards Leng Kee Road, on lane 2 of the 2-lanes. As he was travelling past a slip road on his left, the Deceased had crossed the road from his left to right side and collided on to the left side of his motor car. Due to the accident, the Deceased sustained multiple injuries and was conveyed to the Ng Teng Fong General Hospital by ambulance. The Deceased was reported to be unconscious and suffered a cardiac arrest. She succumbed to her injuries and was pronounced dead in the said hospital on the same day at 10.27 a.m., by Dr Daniel Goh En Qi.

**i) Case IAFP-IB-20190820 - Mechanical Inspection of Prime Mover XE3684 X (TP/IP/50073/2019)**

On 13 August 2019 (Tuesday) at about 1.23 p.m., the Deceased was believed to be cycling across the zebra-crossing along the slip road of Tampines Industrial Ave 3 into Tampines Ave 10 when he collided onto the left front portion of the Involved Party's vehicle. After the collision, B2 did not stop at the scene. The Involved Party was later traced through LTA cameras. Due to the accident, the Deceased was reported to be unconscious and was conveyed to Changi General Hospital by ambulance. The Deceased succumbed to his injuries and was pronounced dead in the said hospital on the same day at 2 p.m., by Dr Terence Chong Kee Liem.
