- (a) The vehicle sustained damages at the rear portion and o/s body. The chassis frame and body structure affected due to collision. (Details see photographs enclosed)
- (b) In view of this, we are of the opinion that it would be unsafe to proceed with the repairs due to extensive damages on the chassis under the category of the section 2 of THE ROAD TRAFFIC ACT on THE MOTOR VEHICLES (CONSTRUCTION AND USE) (AMENDMENT NO.2) RULES 1989, that:

no vehicle shall be fitted with a replacement chassis or any body part where the chassis is an integral part of the vehicle. and we therefore recommend it to be written off as "Total Loss"
