Brief Details.

On 07/08/2019 at about 5:49 pm, my husband (Lim Sze Hien, NRIC no: S7722915I) was driving his car (white Mitsubishi Outlander, registration no: SLT3056Y) along Tampines Expressway (TPE) and was near to exit 3A (leading towards Tampines Avenue 12). I was sitting in the front passenger seat. I wish to state that the road surface was wet as it was raining heavily earlier, and currently, it was drizzling. Suddenly, the driver of the car (white Audi, registration no: SMD6042P) in front of us stepped on the brakes. My husband then proceeded to apply the brakes on our car in order to avoid a collision. However, our car collided with the rear of the white Audi.

Shortly after, we heard a thud coming from the rear of our car. We then realized that the driver of another car (black Mercedes Benz, registration no: SJP4506D) could not stop in time and collided with the rear of our car. Due to the wet road surface, our car slid forwards and collided onto the rear of the white Audi for a second time.

After the accident, we alighted from our car and so did the drivers and passengers of the white Audi and black Mercedes Benz. Thereafter, my husband and I inspected the damages to our car. The front bumper of our car has damages, and so is the front registration plate. The rear bumper of our car also sustained damages. I also wish to add that the lock sensor for our has malfunctioned due to the accident.

At this point in time, my husband and I did not sustain any injuries as such there was no medical assistance called to the accident scene. We then exchanged particulars with the other two drivers and subsequently left the scene. As such, Traffic Police was also not called to the scene.

Later, I felt pain on my back and also my waist area. My husband also felt pain on his back. We then proceeded to Khoo Teck Puat Hospital for a medical check-up. I received a 7 days MC (outpatient), whilst my husband received a 1-day MC (outpatient).

Our car is currently at the car workshop.
