Dear Mr Lo, Ms Mok

We understand you concern on the repair cost and have re-visited the claim.

We wish to explain that this accident was of side swipe nature and both vehicles were moving. Our vehicle is an oil tanker, which is significantly larger in size and heavier than the third party taxi. It is not uncommon to find minor or no damage to the larger size vehicle as compared to the smaller size vehicle, which will usually sustain severe damage.

For this case, our surveyor had inspected the third party taxi and although the exterior seem to show relatively minor damage, when the advertisement was peeled off, the true extent of damage was revealed (we attach report with explanation on the damages on the third party taxi for your perusal).

With regards to the part prices, the damaged third party taxi is a Hyundai I40 and is not sold in the local mass market. M/s ComfortDelgro Engineering sources for, ships in, and supplies the parts. Prices are hence exclusive to M/s ComfortDelgro. The part prices for this case is the standard pricing applied by M/s ComfortDelgro for their Hyundai I40 fleet of taxis.

Our surveyor conducted a re-inspection of the taxi after the completion of its repair and confirmed that the repairs carried out were in order. All parts recommended to be replaced were replaced accordingly by the third party repairer.
