We refer to the above matter.

Our Insured driver only lodged police report and no SAS report to date.

Based on all documents at hand and third party's accident video (as attached), we noted that Insured driver reversed and collided into third party vehicle. We are of the opinion that liability is 100% against Insured and the traffic police outcome is against Insured driver for careless driving under Rule 29.

Please advice if Insured had already made the SAS report and if yes, please send us a copy of the Insured GIA and full copy of Insured's police report.

And if not, kindly let us have your approval on whether we may proceed to settle the Third party claim based on the Insured's police report and to offer repairer "**SMRT TAXIS PTE LTD**" at **\$4,967.19 (all-in).**
