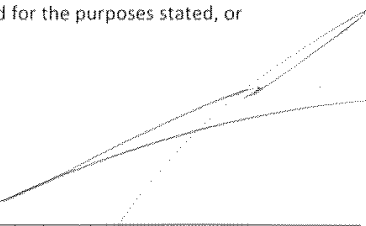

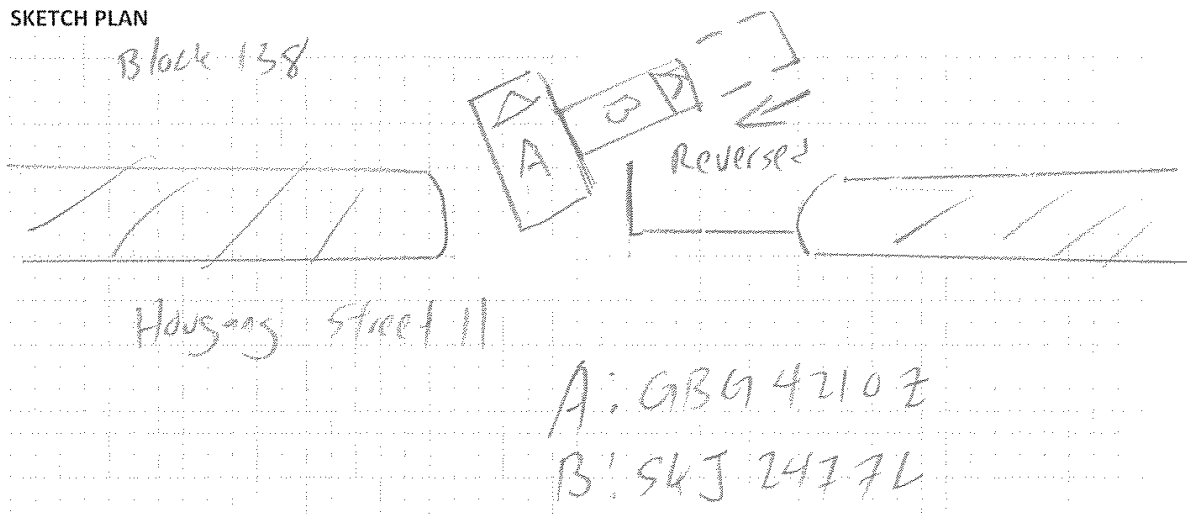

SKETCH PLAN



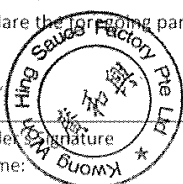
