- ① On 10-8-19 Sat @ 12.45pm I drove out of the car park lot from 3rd flr car park lot @ Sim Lim Tower. (I parked here everyday as I work for a company @ 02-25 Sim Lim Tower as a Technician)
- ② To get down and out to Jalan Besar Main Road I hv to drive pass through a spiral drive-way. This drive-way is a 2-way up/down drive-way. The driveway up/down is separated by a white drawn line at abt its center.
- ③ Abt 30 meters from the exit driveway down a van was on its way up and I was on my way down. The van was driving near the center line and my car was also close to the center line. Suddenly I heard a "bang".
- ④ I pulled a stop and get down so did the van driver. I inspected the van, there was dent on its rear near the rear wheel on the right side. See illustrated area. I hv also inspected my car front and there was also a dent on the mud guard area. (see illustration).
- ⑤ Becos it was @ peak hour @ 12.45pm. There were several cars honking at us. So I gave particulars of ICs. Unfortunately mine was written on a piece of paper and I hv misplaced it. However I hv taken

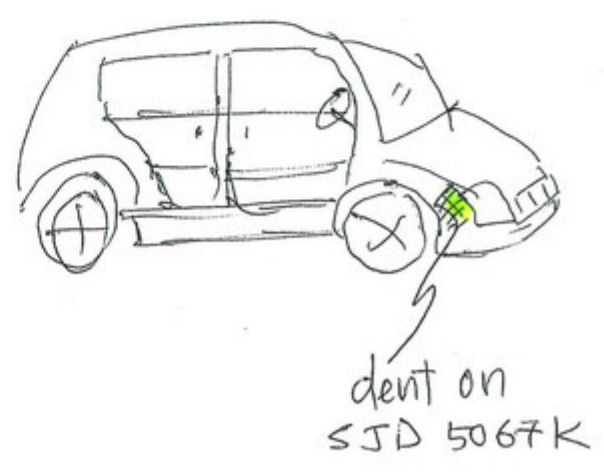
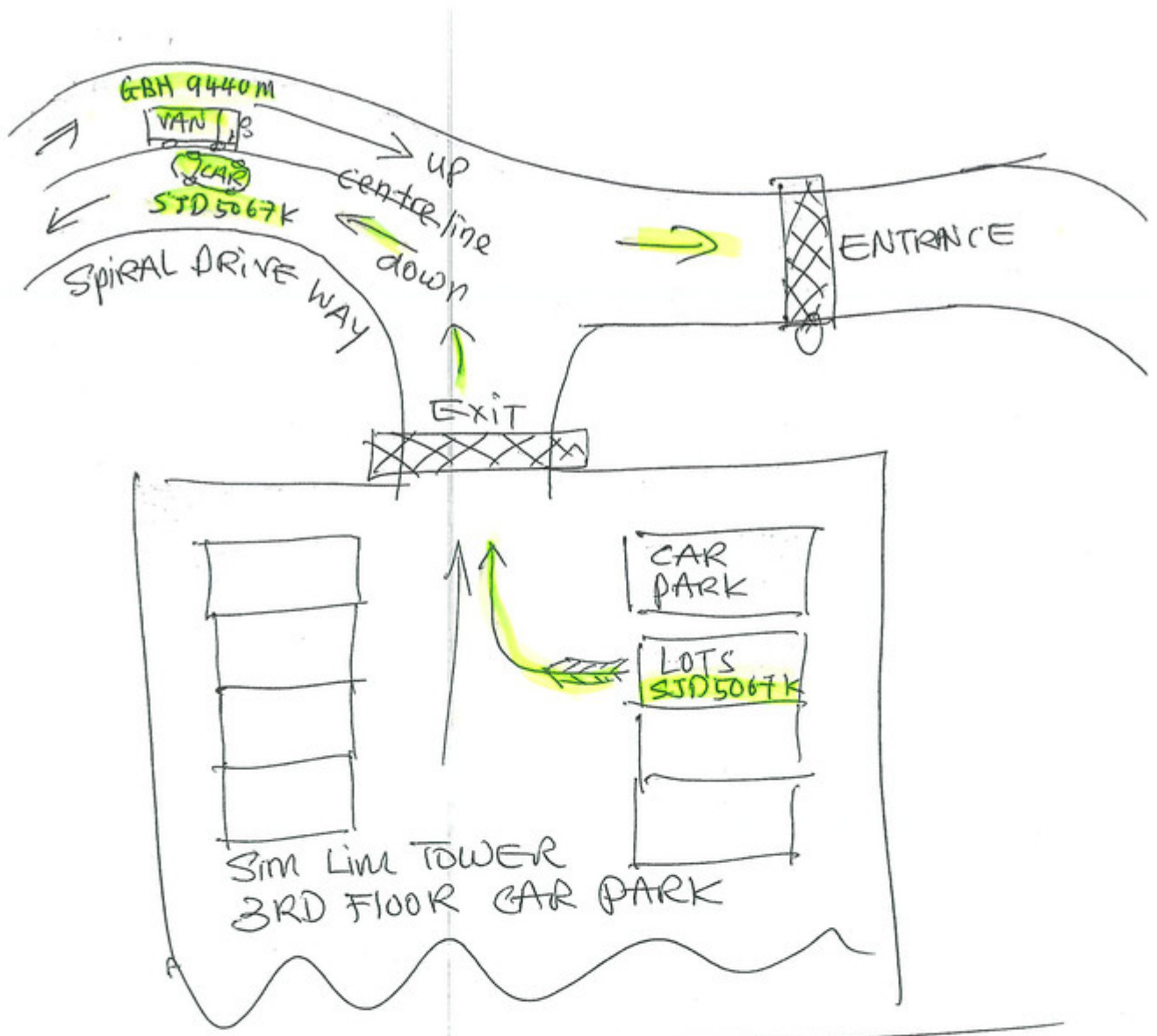
a picture of the Van's rear number plate.
