SLF87b wheel hardly any scratch but my right back bottom bumper got a small hole, this happens too fast.



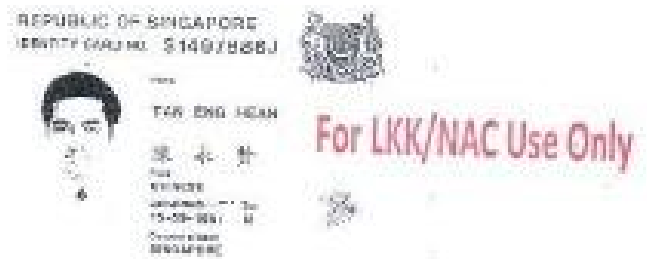
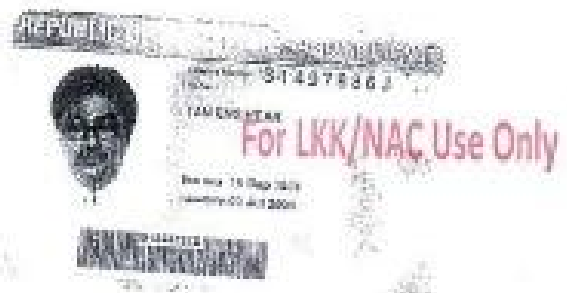
