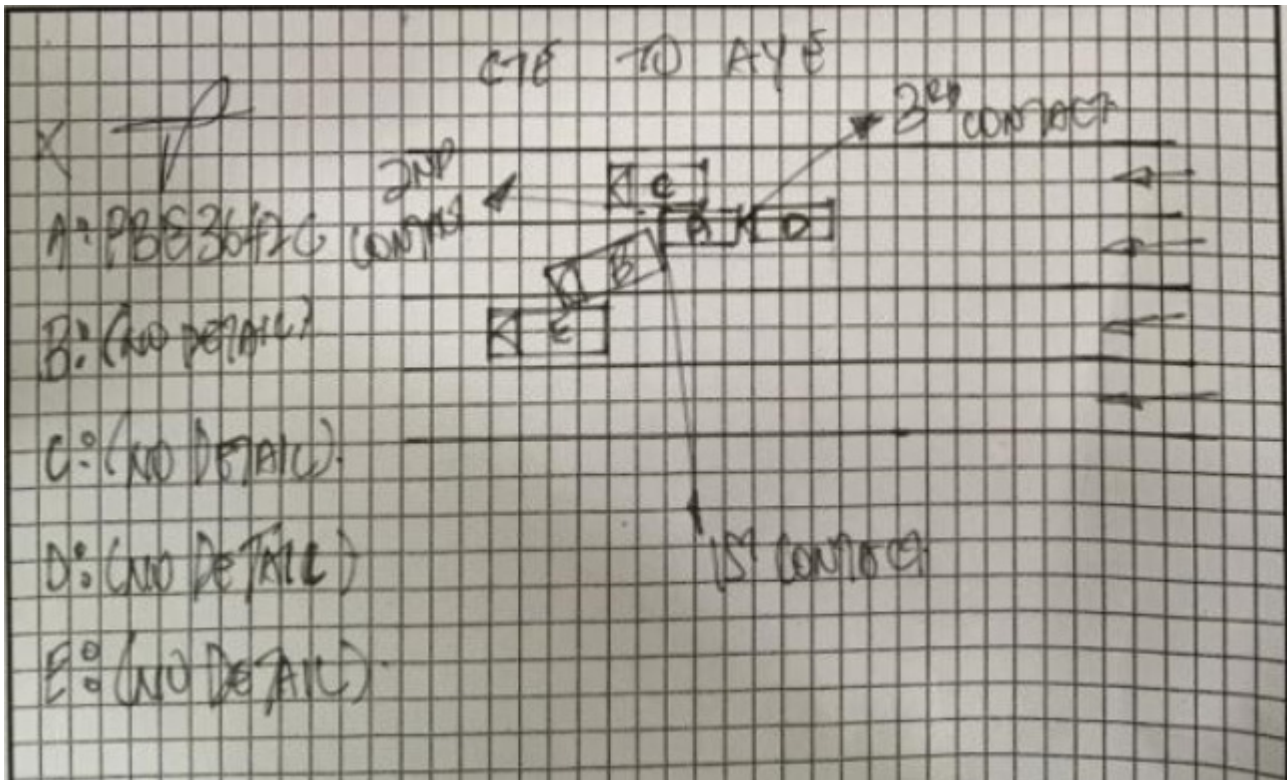


Noted that you are handling PD claims of GBC9511T and FBE3642C.

We are of the view that BOLA 28(I) is applicable for this accident. The sketch plan of FBE3642C (Direct Asia) best illustrates this accident. Under BOLA 28(I) veh C is OIV, which swerved left and hit veh E (GBC9511T). Then, veh B (FBE3642C) rear ended OIV, followed by veh A (FBN9445T) rear ended veh B which fell and hit veh D (SHC242H). No contact between OIV and veh D.

Kindly direct the PD claim from FBE3642C to insurer of FBN9445T, NTUC Income, under BOLA 28(I).
