Brief Details.

On 17/08/2019 at about 1635hrs, I was driving my vehicle bearing the registration plate number SGQ6753Z along Clementi Avenue 2 towards West Coast. At the point of time, the road was dry and the traffic volume was light. I was traveling on the right lane of 2 lane road.

Upon reaching the carpark entrance of Blk 363 Clementi Ave 2, I noticed a dark colour vehicle bearing the registration plate number SKG6530E, exiting the carpark and I continue to travel straight. Suddenly the dark color vehicle did not stop at the line after exiting the carpark, I was in shock and immediately jammed brake however could not stop in time. I then collided into the rear right of the dark colour vehicle.

After the collision, I shifted my vehicle to the left lane and I alighted the vehicle through the front passenger door as I noticed that my driver door could not opened. I saw the driver of SKG6530E was outside her vehicle taking photos.

Clementi Police came at first followed by Ambulance and Traffic Police to render assistance. I do not have a In-car camera installed in my vehicle. I was conveyed by Ambulance to NUH as I felt giddy and was given 2 days of MC from 17-08-2019 to 18-08-2019. There is dent and scratches on my front bumper, bonnet, headlight damaged, driver door damaged and front right wheel damage.
