

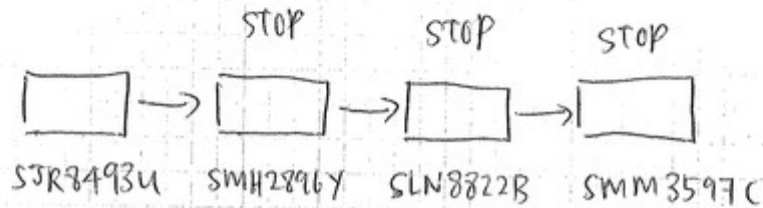

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 16 AUG 2019, I WAS DRIVING ALONG SELETAR EXPRESSWAY. MY VEHICLE CAME TO A GRADUAL STOP DUE TO TRAFFIC NEAR EXIT 9. THE CAR BEHIND ME ALSO CAME TO A STOP, SO DID THE FOLLOWING CAR (SMH 2896Y). HOWEVER, THE LAST CAR (SJR8493U) DID NOT STOP IN TIME AND COLLIDED WITH THE CAR IN FRONT (SMH2896Y). THIS CAUSED A CHAIN COLLISION THAT IMPACTED BOTH SLN8822B AND MY CAR. MY REAR WAS DAMAGED BUT THE FRONT WAS FINE AS I DID NOT COLLIDE WITH THE CAR IN FRONT OF MINE - A TRAFFIC POLICEMAN SOON ARRIVED AT THE SCENE. THERE WERE NO INJURIES SUSTAINED.
