AT AROUND 13:15 HRS ON 16.08.2019, I WAS DRIVING MY CAR SJG3658C ALONG BUKIT TIMAH ROAD TOWARDS THE DIRECTION OF UPPER BUKIT TIMAH ROAD ON THE RIGHT LANE OF THE 3 - LANE DUAL CARRIAGEWAY, AT THE SPEED OF APPROXIMATELY 50 KM/PH WHEN A BLUE CAR SKA1860S WHICH WAS TRAVELLING ON THE LEFT LANE INITIALLY, THEN FILTERED TO THE CENTRE LANE AND ABRUPTLY CUT INTO MY LANE, ENCROACHING MY PATH, RESULTING IN A COLLISION. THE CENTRE AND RIGHT LANE HAS A DOUBLE WHITE LINE AT THE POINT WHEN THE OTHER CAR CUT IN.

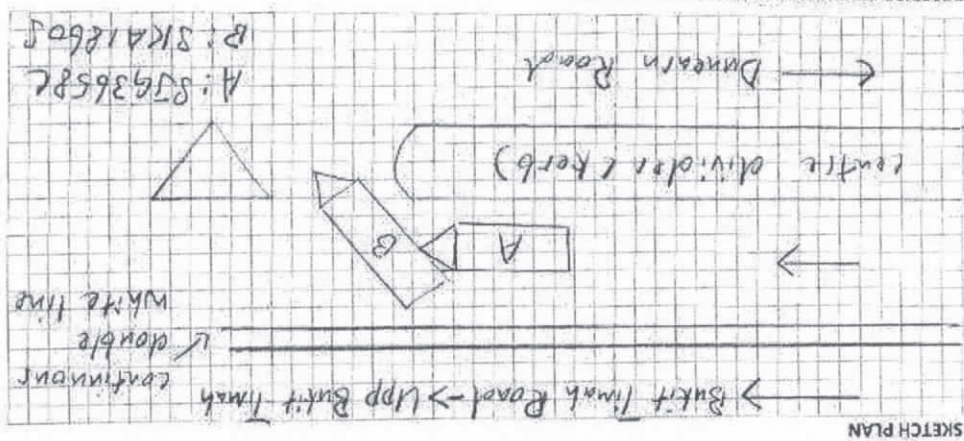

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At around 13:15 hr on 16.8.2019, I was driving my car SJA3658C along Bukit Timah Road towards the direction of Upp Bukit Timah Road on the right lane of the 3-lane dual carriageway, at the speed of approximately 50 kmph when a black car SJA1860J which was travelling on the left lane initially, then filtered to the centre lane and abruptly cut into my lane, encroaching my path, resulting in a collision. The centre and right lane has a double white line at the point when the other car cut in.
