

**Brief Details.**

On 19/08/2019, I was driving my vehicle bearing registration number SLK53Y and had parked my vehicle at the parallel parking along Tagore Lane. I parked my vehicle at around 1630hrs. Everything was normal and intact. On the same day, I returned to my vehicle at 1810hrs and noticed that the driver side mirror broken. Upon further checks, I noticed the side mirror cracked and the side mirror cover was on the ground at the road. I also noticed some scratches at the driver side door. A driver who was inside his vehicle parked in front of me, did not noticed the accident however he informed that he heard a loud bang and subsequently noticed a lorry driving past with the rear doors swung opened. The driver's in car camera had captured the lorry's registration number as YP6593K. I then made a check on my in car camera and it captured a loud bang sound once the lorry passed by my vehicle. My camera also showed the lorry's rear door was not secured properly. It then showed the lorry passenger alighting to make a check on my vehicle before quickly moving off. The accident captured on my in-car camera was at 1723hrs. There was also another person who witnessed the accident working nearby. I do not have his details however I am able to get hold of him as I know where he is working at.
