Brief Details.

On 17/09/2018 at about 0810hrs, I was driving my vehicle (SGD2008L) along Havelock Road towards Upper Pickering Street at the traffic light junction. It was four lanes, I was driving at the 2nd lane from the left and it was heavy traffic jam. While moving slowly, vehicle B (SKG14T) from the left lane drove to my lane in front of me (I could not recall if vehicle B signal to alert me that the driver will be driving to my lane) and I came to a stop.

Subsequently, I change lane to the right and side by side with vehicle B as the traffic light was red. The driver of Vehicle B wind down her window and informed me that she felt that I hit her rear bumper on the right side. I told her lets alight our vehicle and check for any damages but she did alight from her vehicle, the traffic turns green and she drove off.
