CONTINUATION OF REPORT

Brief Details.

On the 17/08/2019 at around 1620hrs, I was driving my silver colour car bearing registration no. SGN8618J and travelling on the 2nd lane along PIE (towards Tuas, after Eng Neo exit).

Out of sudden, one black colour car bearing registration no. SJK5376X who was travelling on the 3rd lane had collided onto the left side of my car. Due to the collision, my car swerved into the first lane however I managed to re-enter back to the 2nd lane. It continued moving and the front part of my car had collided onto the rear bumper of one black colour car bearing registration no. SJY7676Z who was travelling in front of my car.
