

The vehicle shead of me wanted to avoid the collision as such he applied an emergency brake. I fried to do emergency brake as well but was unable to brake in time.

My venicle front portion is badly densed

I would eash to state that none of us are injured during the point of accident. And the accident is due to an unknown sehicle who beat the red light.

I have a video recording device installed inside the vehicle aiming at the front direction which captured the whole incident.
