



 - (ii) investigating the accident and/or my claims;
 - (iii) carrying out and/or dealing with my instructions or responding to any enquiries by me;

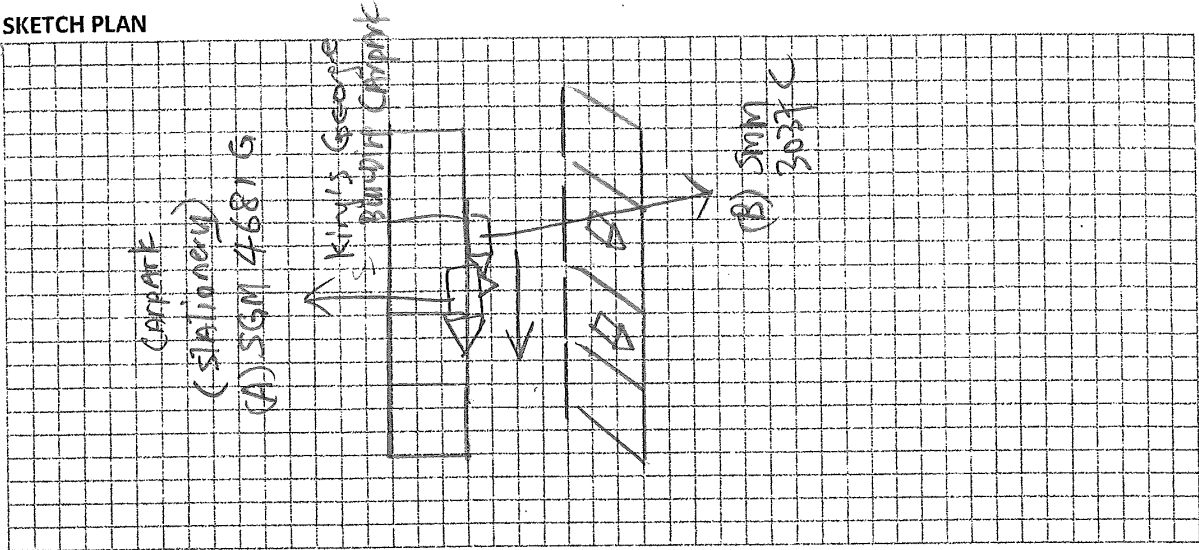

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On 23/8/19 at about 6:40pm. I was stationary my

 SMM 3037 C for my damages


