

I understand, acknowledge, agree and consent that:



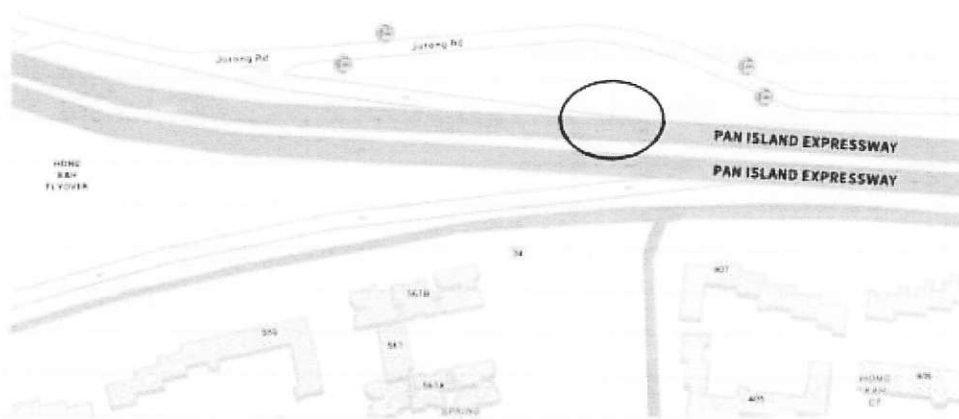

The accident happened on 24 Aug 2019 around 1.30pm on the slip road after Jurong West Ave 2 into PIE in the direction of Changi Airport. The Truck (XD7066J) drove by Mr Chinniah Murugesan of Koh Kock Leong Enterprise Pte Ltd banged into the driver's side back door of my car (SFJ3292E).



At the time of the accident, there was a massive jam along PIE and all the vehicles were crawling. Together with all other vehicles on the slip road, I was merging slowly into PIE and was behind the Lorry (YL4511G) which merged right into PIE in front of the Truck (XD7066J). Even though there was sufficient space to filter in behind the Lorry (YL4511G), taking safety into consideration, I drove further ahead so that the Truck driver could see me merging-in. I was already about halfway into the left lane of PIE. When the traffic started moving again and my car was still stationary, the Truck moved and banged into the driver's side back door of my car. In order to limit the degree of damage, I had to quickly steer to the left.

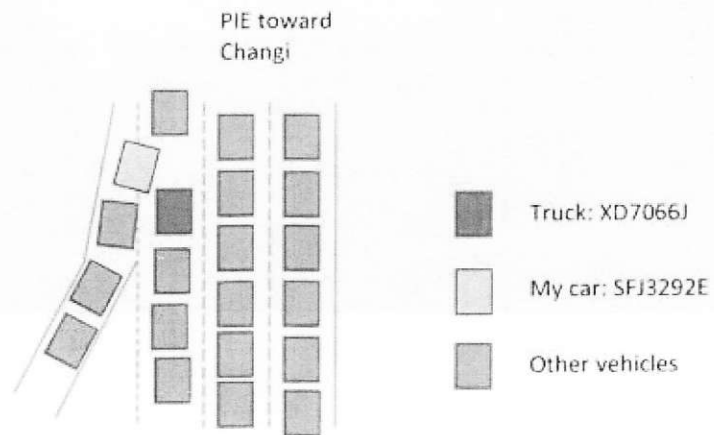


Diagram showing moment of impact.
