



Before I head out, I make sure that I checked the right side of my car, ensuring that there was no incoming vehicle. As there was a column and a van parked on the left side of my vehicle. I have no choice but to inch my car out slowly to check for incoming vehicles coming from my left. As I was moving my car out of the lot at a slow speed, a BMW (SLL4777K) that was driving in the centre of both lanes hit my car resulting in a huge impact to be experienced while I was in the car. Do take note that my car has not went over to the other lane yet. Prior to the accident, my car's headlight was on and thus the road was lighted hence no excuse for the driver of SLL4777K to not know the presence of my vehicle. On top of that, the driver of SLL4777k was driving on a straight road hence having the advantage of a better vision. Last but not least, the driver did not horn nor did anything to warn me of her presence, showing that she was obviously not paying attention while she was driving.




