We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a third party claim(s) from CHENG HOE MOTOR PL acting on behalf of the owner of SKF2096Z against your motor insurance policy.

Based on the accident report and accident scenario, liability is not in your favour as your vehicle had filtered into third party's lane and hit onto third party vehicle.
