DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling at AVE towards Twas in Lane 1 and the traffic was heavy. I intended to change to the second lane as the traffic was moving smoother, while I was changing lanes I saw vehicle B suddenly indicate his signal to the left and tried to move in to the second lane. Upon seeing his action, I tried to manoeuvre to the right side of the first lane but I realised there wasn't enough time to overtake the vehicle. I then slammed on my brakes and lost traction which makes my bike skid and hit his bumper. After this incident, I and vehicle B driver exchange particulars and wanted to settle this matter privately. While we were discussing, there was a pillion by car stopped and communicated with vehicle B driver. After their communication, vehicle B driver wanted to claim my insurance. I suffered from few slight abrasions.
