

### SKETCH PLAN



THE ACCIDENT OCCURED WITHIN THE OPEN-AIR CAR PARK AT THE SINGAPORE ZOO ON SATURDAY, 24 AUG 2019 AT APPROX. 2PM. I WAS DRIVING OUT OF MY PARKING SPACE AND TURNING RIGHT TO ADJOINING CARRIAGEWAY. AS THERE WERE SEVERAL VEHICLES PARKED ILLEGALLY ALONG THIS CARRIAGEWAY, IT OBSTRUCTED MY VIEW OF ONCOMING VEHICLES. NEVERTHELESS, I HAD CHECKED TO SEE & SLOWED DOWN MY VEHICLE AT THE JUNCTION. AS I SLOWLY STARTED TO TURN OUT INTO THE ADJOINING CARRIAGEWAY, A FAST-MOVING VEHICLE FROM THE LEFT CUT IN FRONT OF ME, HITTING THE FRONT BUMPER OF MY VEHICLE & DISLODGING MY FRONT LICENSE PLATE. THE OTHER VEHICLE SUFFERED SCRATCHES TO THE DRIVER'S SIDE OF THE VEHICLE.

AFTER SPEAKING WITH THE DRIVER OF THE OTHER VEHICLE, THE OTHER DRIVER EXPLAINED THAT SHE WAS RUSHING TO THE PICK-UP POINT TO PICK UP HER GRANDCHILDREN. THE CAR SHE WAS DRIVING BELONGS TO HER SON-IN-LAW (WHO WAS NOT IN THE COUNTRY AT THE TIME.)
