Your Vehicle SJT5753D Has Been Deregistered

The above-mentioned vehicle was deregistered on 13 Sep 2019. If the vehicle is yet to be disposed of, you should do so by 13 Oct 2019. Scrap it (including the engine and chassis) at an LTA-authorized scrapyard or submit to LTA documentary proof that the vehicle has been permanently exported out of Singapore. Otherwise, it is an offence and the penalty is a fine of up to \$2,000 and imprisonment of up to 3 months for the first offence. Subsequent offences carry heavier penalties.
