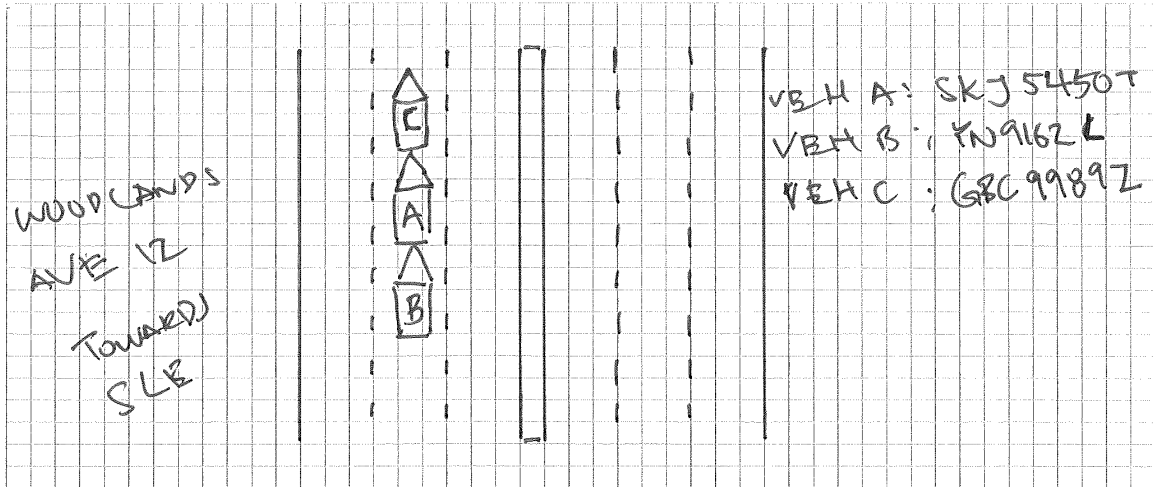

ON THE ABOVE STATED DATE AND TIME, I VEH A SKJ5450T WAS TRAVELLING ALONG WOODLANDS AVE 12. I GRADUALLY CAME TO A STOP BEHIND VEHICLE C GBC9989Z AS THE TRAFFIC LIGHT WAS RED. I WAS STATIONARY AWAITING THE TRAFFIC TO MOVE OFF. A FEW SECONDS LATER I FELT AN IMPACT ON MY VEHICLE REAR PORTION, DUE TO COLLISION OF VEHICLE B YN9162C.
