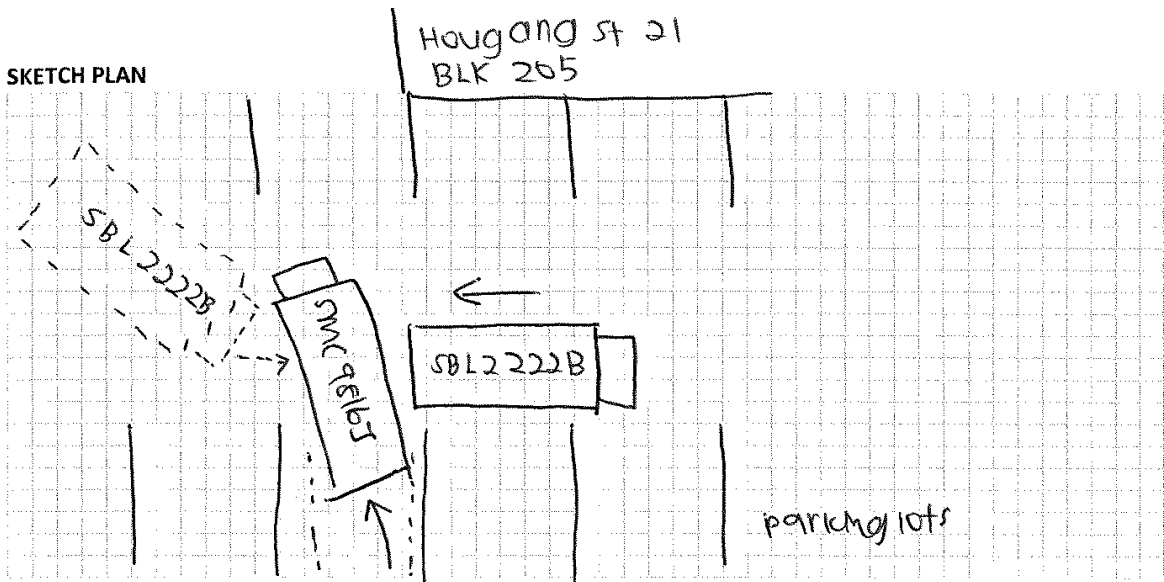

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was parked at carpark nearest to Hougang St 21 BLK 205
preparing to exit my lot when I saw SBL 2222B enter the
carpark area and drove past my car. The vehicle then came to
a complete stop to my right side. After confirming that there was
no further movement from SBL 2222B, I then checked the right
side view followed by left side view to ensure traffic was clear before
I exited my lot. It looked like he was waiting for my lot since he stopped
completely and the carpark was packed.
While I was halfway through exiting my lot, I noticed that at a low speed,
SBL 2222B started to reverse (seemingly waiting for me to
exit the lot and trying to place his car nearer to my lot so that
it would not be snatched away by other cars). I then honked
when he approached me far too close to alert him but moments
later, he have knocked into the side door of driver seat.
