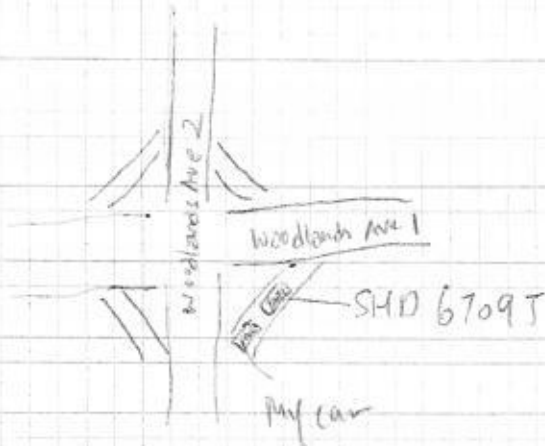

SKETCH PLAN






