1. With reference to the highlighted portion at [28], we confirm the contents thereof.
2. Also, at [13], the affidavits were referred to as "**Affidavit-In-Chief**" and "**AEIC**". As a matter of terminology, these documents are not referred to as AEICs. We suggest that the words "**Affidavit**" and "**Affid**" can be used respectively, e.g. "**Affidavit of the Plaintiff**", "**Plaintiff's AFF-1**", "**Defendant's AFF-1**" for all subsequent references. We enclose herewith our proposed comments in red.

We have arranged for a commissioner for you on 12 September 2019 (Thursday) at 3.30pm.

Kindly also let us have your invoice made payable to our firm, and we will proceed to obtain half the sum from the Defendant's solicitors M/S L G Roberts.

Dear Bryan,

1. We are glad to inform you that pursuant to the Order made by District Judge Kevin Kwek ("the DJ") at the Case Management Conference before him on 15 August 2019, you have been appointed as the Single Joint Expert ("SJE") for MC/MC 14193/2018.
2. Your appointment is on the basis of your fees as stated in your email dated 3 January 2019. Your professional fees / rates (i.e. \$1,200) for preparation of technical report plus \$600 for a half-day trial or \$1,200 for a full day trial, subject to GST) will be shared between the parties initially, and Final Order on the payment of your professional fees will be reserved till further decision by the Civil Trial Judge hearing the matter.
3. Your AEIC as ordered by the DJ is due on 12 September 2019. As such, we will be arranging a meeting sometime next week at our office with yourself, the Plaintiff and his wife. Kindly let us know your available dates next week so that we can arrange for a meeting between the relevant parties.
