#### Brief Details.

On 30.08 2019 at about 0825hrs, I was riding my motorcycle travelling along Upper Thomson Road towards Arig Mo Kio along lane 3. It was raining and the road surface was wet. I was riding slow due to the weather and heavy traffic.

While I was riding, something hit unto my helmet and caused me to lose balance and my motorcycle fell u, to le't side, while I fell unto right side. I believed that something to be the canvas weight from the lorry (YP6413J) which was travelling on lane 2 came loose and hit unto my helmet.

Fr. I was dispriented, someone helped me up and managed to stop the lorry driver. We exchanged p. Yoular and I contacted my Insurance consultant, whom later came to the scene and fetch me to seek mil dical treatment at Intermedical 24 Hr Clinic.

I was certified 5 days MC by the doctor from 30.08.2019 to 03.09.2019 and was refer to Ang Mo Kio X-ray Cinic & Laboratory for X-ray scanning as the doctor suspected close fracture on my right shoulder and right hand. The X-ray results are still pending, and my right hand had already swollen.






