Dear All,

Please note that this claim has been outstanding for a long time despite numerous correspondence with LKK. Could OIC from AIG please assist.

The Release Voucher was submitted on 03 Aug 2016 together with our Tax Claim Invoice for the amount of \$1,476.60 for repairs, Loss of Use for 4 days @ \$30 per day (weekend car) and GIA Search Fee \$2.

On 12 Oct 2016 we were offered a settlement of \$800.00 at 50% liability. On 1 November 2016 we replied to Zayyer (LKK) rejecting the offer and that we have footage of the accident and if they would like to view it. On 1 Nov 2016 we replied to Zayyer rejecting his offer. On 17 November 2016, Zayyer wrote to ask for the video footage. Informed him that video file is too large to send.

When we rang LKK on 11 June, we were told that Zayyer is no longer with them and the he has closed the file. We were advised to write to AIG. We emailed AIGSGP Claims Survey on 12 June 2019. And on 8 July 2019, Mei Kwan from LKK emailed us asking us to provide them with : evidence i.e. video and scene photo, PIR result (if any, LOD. On 12 July we replied that there was no police report made. We send them a copy of the Release Voucher and the Tax Claim Invoice and again advised them that the video file is too big and when their surveyor comes to our office to bring a thumb drive.

Todate we have no further news on this matter. Please review the matter and let us hear from you.
