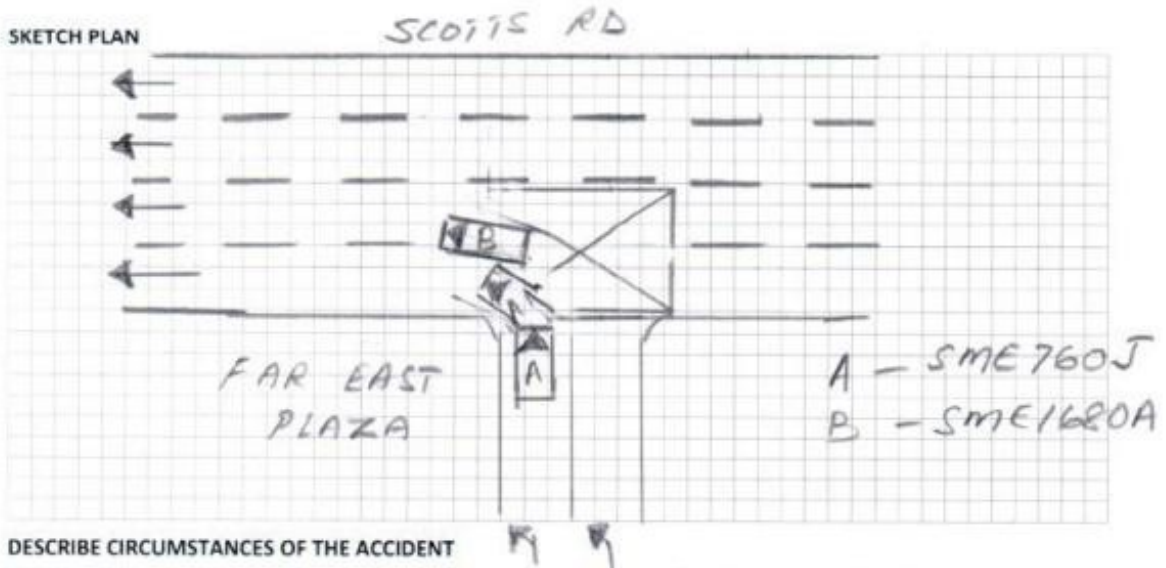

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was in the inner lane and car B was in outer lane, waiting to move out. I waited for car B to move first and checked my inner lane was clear before I slowly moved out. I kept to my own lane at all times, foot still pressing on my brake pedal as I slowly moved out.

Suddenly car B oversteered toward my lane, and it happened so quickly I could not fully stop in time. The left rear side of Car B collided with the front right side of my car.
