Brief Details.

On 19/07/2019 at about 1925hrs, I was riding my motorcycle, A maroon color Honda CB400 along Tuas Road towards Tuas West Road. The traffic volume was moderate. I was on a two lane road, on the second lane. On the first lane beside me, was a large trailer truck of unknown registration number. At point of the road, a large trailer truck had suddenly in a fast manner, started to enter my lane. I honked several times to warn him. However, there was no reaction. I did emergency brake to avoid being squashed. As a result, my motorcycle skidded and I fell, together with my pillion, Mr Hairul.

Immediately after the accident, I noticed that my motorcycle had skidded far in front of me. Someone assisted to pull me over to the grass patch nearby for safety. I asked my friend if the Ambulance has called and he said yes. When the Ambulance arrived, I was brought into the vehicle. We waited for Police to arrive as the trailer driver only wanted to give particulars to the Police. I was then conveyed by Ambulance to Ng Teng Fong Hospital. My Pillion, Mr Hairul followed me in the Ambulance and sought his own medical attention afterwards.

I sustained a deep cut on my left foot which needed about 24 stitches. There's a suspected crack on my right shoulder's bone. There were multiple abrasions on my left and right arms and palms. I was subsequently given 33 days of MC from 19/07/2019 to 20/07/2019.
