CONTINUATION OF REPORT

Brief Details.

On 30/08/2019, I had parked my vehicle bearing SMM3047Z at about 1700hrs at Compass one mall located at 1 Sengkang Square, B2 lot 28. Everything was in order when I left my vehicle.

Upon returning to my vehicle at about 1756hrs, I discovered a note on my front wind screen. The note stated "I SCRATCH YOUR CAR, CALL ME AT 88371268 J". I had checked my vehicle and discovered a long scratch at the bottom rear right side of my vehicle. The rear right side skirt had also protruded out. I had called the number multiple time. However, it was stated "fail". The number was not connected and was directly engaged.

I had view my in-car CCTV footage which revealed earlier at 1733hrs, my vehicle had detected a motion as an impact was reflected in the in car footage. Shortly, a car bearing plate number SMC5861D was seen driving ahead of my vehicle and stopped. A male Chinese had then alighted and pasted a note on my vehicle after which he had then left the place.

Till date, I had tried calling the number however to no avail. I wish to state that when my vehicle sensor motion was detected, there are a few people walking around the vicinity. As such I suspect that the mentioned person had only write the note as there are people around the vicinity that witness the incident.

I had called for police assistance after which traffic police had called advising me to lodge a report regarding the matter. My in car camera had captured the incident.

I am lodging a report for traffic police investigation.


